#### **DILUTION DIRECTIONS**

Ditute 2 2/3 fluid ounces of this concentrate to one gallon with water at ail to make an emulsion or oil solution centaining approximately 0.5% Vapona Insecticide. IF EMULSIONS ARE MADE PREPARE THEM FRESH EACH DAY FOR MAXIMUM EFFECTIVENESS.

#### GENERAL DIRECTIONS FOR USE:

for use in households, restaurants, theatres, food processing plants, industrial plants and warehouses for the control of Cockroaches, Ants, Spiders, Silverfish, Flies, Masquitaes, Wasps, Gnets, apply emulsion or oil solution, prepared as above, as a coarse wet spray to localized areas insects may infest. ### PRECAUTIONS IN USING

VAPONA Insecticide concentrate and the diluted emulsion are poisonous. Therefore, precautions must be observed when handling them. (See antidote and warnings below.)

Store the concentrate in a safe place. Children or animals must not be able to reach or handle the concentrate or diluted emulsion. It is recommended that only the amount of diluted emulsion be prepared from the concentrate that will be used immediately. Mix the concentrate into water outdoors or in a well ventilated room. Wash off the outside of the bottle of concentrate in running water before storing away.

Do not contaminate lakes or streams.

Do not contaminate feed, water or foodstuffs.

### WARNING!

VAPONA Insecticide concentrate is poisonous if swallowed, inhaled or absorbed through skin or eyes. Do not get on skin or eyes. Do not breathe fumes. Avaid prolonged exposure to fumes. Start artificial respiration immediately if patient is not breathing. Transport the patient immediately to the nearest physician.

### NOTE TO PHYSICIAN

WARNING SYMPTOMS: Symptoms include weakness, headache, tightness in chest, blurred vision, non-reactive pin-point pupils, salivation, sweating, nausea, vomiting, diarrhea and abdominal cramps.

TREATMENT: Atropine is the specific therapeutic antagonist of choice against parasympathetic nervous stimulation. If there are signs of parasympathetic stimulation, atropine sulfate should be injected at 10-minute intervals, in doses of 1 to 2 milligrams until complete atropinization has occured.

Morphine is contraindicated.

Clear chest by postural drainage.

Observe patient continuously for 48 hours.

Repeated exposure to cholinesterose inhibitors may, without warning, cause prolonged susceptibility to very small doses of any cholinesterose inhibitor.
