

## DIRECTIONS

Municipal Control of Houseflies and Mosquitoes: Mix 1 gallon Mal-O-Sect with 40 gallons of water. With this solution treat insect breeding areas: garbage heaps, city dumps, sewage disposal areas and livestock pens. Also recommended for alleyways around yards and houses, and around buildings which house domestic animals. Thoroughly wet all surfaces with a coarse wet spray.

For Control of Houseflies and Mosquitoes in Fogging and Mist Machines: Use 1 gallon of Mal-O-Sect to 50 gallons of water. Effective in thermal and mist machines. Treat breeding areas, paying particular attention to garbage heaps, city dumps, sewage disposal areas and livestock pens. Envelop the area in fog.

**COCKROACHES:** Mix 1 gallon Mal-O-Sect to 13 gallons of water, apply as a coarse wet spray to sewer manholes, around building foundations, baseboards, pipes, on garbage dumps and around garbage storage racks.

Repeat treatment when necessary.

On ornamental plants only: to control certain species of aphids, leaf hoppers, leaf rollers, ants, dilute 1 part Mal-O-Sect with 39 parts of water. Spray the foliage to the point of run-off using either a hydraulic or compressed air sprayer. Mal-O-Sect leaves a residual surface. Repeat when necessary.

**CAUTION:** Harmful if inhaled, swallowed or absorbed through the skin. Avoid breathing spray mist. Avoid contact with skin, eyes and clothing. Wash thoroughly. Store away from children or domestic animals. If swallowed, get prompt medical attention.
