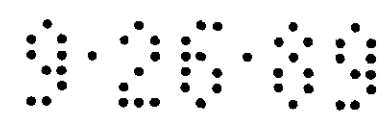

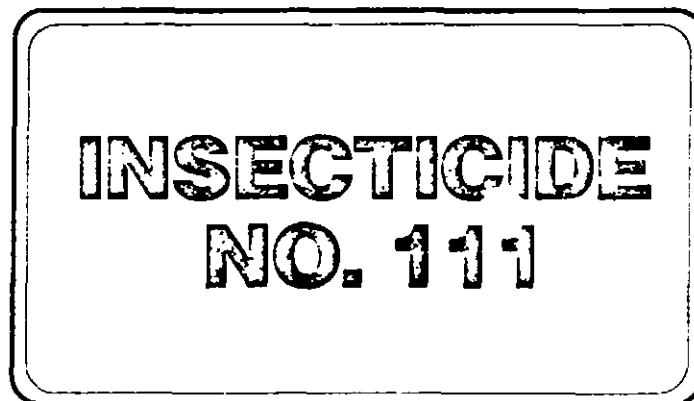

In the control of flies, mosquitoes, gnats, flying moths, direct the spray toward the upper portions of the enclosure and fill the atmosphere with mist, using 2 or 3 ounces to each 1000 cubic feet of space. In the control of wasps, and hornets, direct the spray toward the upper portions of the enclosure and fill the atmosphere with mist, using 8 to 10 ounces to each 1000 cubic feet of space. Against silverfish, crickets, scorpions, spiders and ants, treat all areas where these ants are commonly found, and direct the liquid behind baseboards, mouldings, furniture, cabinets, sinks and pipes; toward drains and dark corners, into cracks, crevices, recesses and similar places.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

STORAGE: If container is damaged, stop any leaks by repositioning the container or by patching or otherwise repairing the leaks. Take care to avoid contact with pesticide and wear protective gear. 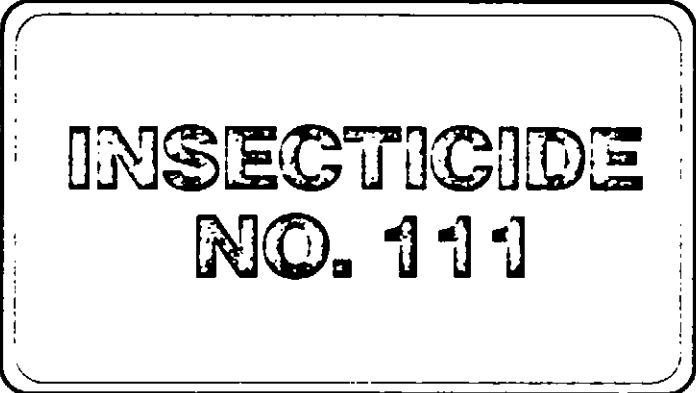
