Northeation for control of aphids and mites as flowers mix is a cost control of leaf hoppers and thrips on cabbages and clover mite on tomatoes mix 1.0 lb, per acre (-12, pts. product per 100 gal.) of water. For control of Japanese beetles on pears use 1 teaspoonful per gallo) of water. For control of Mexican bean beetles on beans mix 1) z teaspoonfuls per gallon of water. FLEA CONTROL - To control fleas in kennels words, lawns and under houses, dilute 5 ounces in one gallon of water and apply at the rate of one gallon of diluted spray per 1000 square feet. Clean area before treatment. Fresh bedding should be placed in animals quarters following treatment. Repeat as necessary, DO NOT APPLY TO DOGS.

MOSQUITO CONTROL - For the control of adult mosquitoes, flies and small flying inesects in outdoor areas, dilute 1 to 28 with water (4½ fl. oz. per gal.) Apply as fine mist or fog. Three fl. oz of concentrate will treat 1 acre. Repeat application as necessary. May cause spotting on automobile paint finish. Cars should not be sprayed directly. If accidental exposure occurs, the car should be washed immediately.

ROACH CONTROL. For control of roaches, ants, spiders and clover mites in and about homes, institutes and industrial plants, dilute 4 ounces per gallon of water. Apply by means of a coarse spray or paint brush to window frames base boards, under sinks, drain boards, stoves, and other areas frequented by inserts. Repeat as necessary. Do not contaminate food or utensils. Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving creas while food is exposed. Do not use where milk is stored.
