Prepare fresh use solution. Discard solutions when disinfected, thoroughly. Surfaces must remain wet to assure proper germicidal action.

This product may be used on hard, non-porous, non-absorbent surfaces (glass, metal, glazed ceramic, leather, vinyl, enamel, walls, floors, appliances).

To Clean and Deodorize Surfaces: Depend on the surface to be cleaned, use 12 to 16 oz. of water.

Hospitals, Veterinary Clinics, etc. (of this product per 1 gallon of water) for one-step cleaning with light to medium disinfection. Pre-clean as described. Use THIS PRODUCT at 5 oz. per gallon.
