#### PRODUCT INFORMATION

For total weed control on certain areas around the business or workplace where no plant growth is desired, use as specified in label directions. Controls bindweed, common mullein, and other hard-to-kill weeds. Prevents plant growth for up to one year.

#### **DIRECTIONS FOR USE**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

For control of annual and broadleaf weeds such as downy bromegrass, oatgrass, goosegrass, quackgrass, puncturevine, goldenrod, plaintain, bindweed, johnsongrass, common mullein and wild carrot. To cover 100 sq. ft., add 10 - 18 fl. oz. by use of a sprinkling can or other watering or spraying device in sufficient water to get good coverage of the area (e.g., 2 1/2 gals. in sprinkling can). Limited to 1 application per year. The maximum use rate is 0.20 lb ai/500 ft², or the equivalent to a maximum of 18 lbs ai/A (18 oz. of this product per 100 sq. ft.) Different grades of mineral oil, diesel fuel, petroleum-based-oil, fuel oil, or kerosene may be substituted for water.

When using a sprinkling can, triple rinse and pour rinsate on area treated once application is completed. Mix only the quantity needed and use immediately. To minimize lateral movement, sprinkle lightly with a watering can or similar sprinkler device immediately after application.

This product will not provide herbicidal action in the treated area unless application is immediately followed by watering the area with at least 1/4" of water or application of the product just prior to a rain event sufficient to penetrate to the root system of the target vegetation.

#### **USE RESTRICTIONS:**

- Do not apply this product in a way that will contact workers or other persons, either directly or through drift.
- Only protected handlers may be in the area during application.
- Do not enter or allow entry until sprays have dried.
- Do not apply this product in a residential setting.
- Weeds greater than 4 inches must be mowed, removed, or hoed into the soil prior to application.
- Do not use this product on or near desirable plants, including within the dripline of the roots of desirable trees and shrubs, since injury to desirable plants and other vegetation may result.
- Do not use this product to sloped areas where desirable vegetation or nearby water bodies may be located downhill of the application area, since injury to desirable plants and other vegetation may result.

**USE PRECAUTIONS: SPRAY DRIFT MANAGEMENT:** A variety of factors including weather conditions (e.g. wind direction, wind speed, temperature, relative humidity) and method of application (e.g. groundboom, sprayer) can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product. Use only Medium or coarser spray nozzles according to ASAE (S572) definition for standard nozzles. Do not apply at wind speeds greater than 10 mph.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**PESTICIDE STORAGE:** Store at temperatures above 32 deg. F. Do not use or store near heat or open flame. Keep container closed when not in use. **PESTICIDE DISPOSAL:** Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

**CONTAINER DISPOSAL** - (For containers greater than 5 gallons): Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

(For containers equal to or less than 5 gallons): Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.
