PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For <u>Control of Wasps and Hornets</u>: It is preferable to apply this product in the evening after all the insects have returned to the nest. Aim valve opening at the nest and depress button, continuing to spray until the nest is soaked with the spray. Repeat as necessary.

STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area away from heat or open flame.

<u>DISPOSAL</u>: Replace cap and discard container in trash. Do not incinerate or puncture.
