If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

4. Revise the statement "STORAGE AND DISPOSAL Do not contaminate water, food, or feed by storage disposal. Do not store on side. Avoid creasing or impacting of side walls." to read:

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE**: Do not store on side. Avoid creasing or impacting of side walls.

5. The ingredient statement must total 100%.

- 1. Remove gross filth and heavy soil deposits.
- 2. Direct a coarse spray onto surface for 10 seconds from a distance of about 12 inches.
- 3. Allow foam to wet surface for 10 minutes.
- 4. Rinse surfaces thoroughly with water.

FOR GENERAL CLEANING AND DEODORIZING of hard non-porous surfaces: Dilute up to 1:10 with water and apply with a mop, sponge, cloth, or a trigger sprayer. Rinse thoroughly with water.
