

DIRECTIONS FOR USE _Betz Slime-Trol RX-15 is a bacteriological slime growth-control agent for use in paper and paper pulp mill process systems.

Betz Slime-Trol RX-15 should be added to the wet paper or pulp stock at the rate of 0.5-2.0 pounds, or 0.015-0.06 quart, per short ton of dry paper or pulp produced. Addition may be made to the beater, beater chest, Jordan headbox or chest, machine chest, or the white water system. The product may be fed continuously or intermittently by a proportioning pump, by drip-feed apparatus or directly from the drum. The rate of feed is dependent upon the type of system and the severity of the microbial problem.
