Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and

forth several times. Empty the rinsate into the treated system or store rinsate for later use or disposal. Repeat this procedure two more times.

CONTAINER DISPOSAL: Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal. empty the remaining contents from this container into application equipment or a mix tank. Fill the container about 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.

This product aids in the control of control of algal, bacterial and fungal biofilm in evaporative condensers, heat exchange water systems, commercial and industrial cooling towers, industrial water scrubbing systems and brewery pasteurizers. Add this product to the tower basin, distribution box or some other point to insure uniform mixing. BADLY FOULED SYSTEMS must be cleaned before treatment is begun.

INITIAL DOSE: When the system is noticeably fouled, apply this product at the rate of 20 to 120 ppm of this product (0.2 to 1.0 pound or 2 to 12 fluid ounce) of this product per 1,000 gallons of water in the system. Repeat until control is achieved. SUBSEQUENT DOSE: When microbial control is evident, add this product at the rate of 5 to 30 ppm of this product (0.04 to 0.25 pound or 0.5 to 3 fluid ounce) of this product per 1000 gallons in the system weekly or as needed to maintain control.

AIR WASHER SYSTEMS

For use only in industrial air washing systems that maintain effective mist eliminating components. To control bacteria, fungi and algae which cause biofouling in industrial air washer systems, add this product to the air washer sump or chill water sump to insure uniform mixing, at the rate of 5 to 120 ppm of this product (.04 to 1 pound or 0.5 to 12 fluid ounce) of this product per 1000 gallons of water in the system depending upon the severity of contamination. BADLY FOULED SYSTEMS must be cleaned before treatment is begun.

INTERMITTENT OR SLUG METHOD

INITIAL DOSE: When the system is noticeably fouled, apply this product at the rate of 20 to 120 ppm of this product (0.2 to 1 pound or 2 to 12 fluid ounce) of this product per 1000 gallons of water in the system. Repeat until control is achieved. SUBSEQUENT DOSE: When microbial control is evident, add this product at the rate of 5 to 30 ppm of this product (.04 to 0.25 pound or 0.5 to 3 fluid ounce) of this product per 1000 gallons of water in the system weekly or as needed to maintain control.

INDUSTRIAL WASTEWATER TREATMENT SYSTEMS AND SEWAGE SYSTEMS
This product is recommended for the control of microbial biofilms, bacteria, fungi, and algae in industrial wastewater treatment and sewage systems. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority.

INITIAL DOSE: When the system is noticeably fouled, apply 20 to 120 ppm of this product (0.2 to 1.0 pound or 2 to 12 fluid ounce) per 1,000 gallons of water in the system.) Repeat until control is achieved. Badly fouled systems should be cleaned before treatment is begun.

SUBSEQUENT DOSE: When microbial control is evident, add 5 to 30 ppm of this product (.04 to 0.25 pound or 0.5 to 3 fluid ounce) per 1,000 gallons of water in the system weekly or as needed to maintain control.
