### DIRECTIONS

**?OACHES** - Use a coarse wet spray or paint brush and apply on a "spot" basis only to infested cracks and other hiding or resting places. Repeat application as often as necessary.

SILVERFISH - Use a coarse wet spray or paint brush and apply on a ''spot'' basis only to infested cracks and other hiding places, such as, behind shelving, bookcases, storage areas and around baseboards. Repeat opplication as required.

ANTS - Use a coarse wet spray or paint brush and apply on a "spot" basis only to areas around door sills, window frames, openings around water pipes, heat ducts, electrical outlets and baseboards, paying particular attention to ant trails. Repeat application as often as necessary to maintain effective control.
