**DIRECTIONS FOR USE**

**SPRAY ONLY ON HARD SURFACE. DO NOT USE AS A SPACE SPRAY.** is a violation of federal law to use this product in a manner inconsistent with its labeling. This formulation may be used as a contact spray against crawling insects. As a residual insecticide, it will provide up to 3 weeks of control of roaches. Shake well before use. Remove protective cap. Aim spray opening away from person. Push button to spray.

**ROACHES, EARWIGS, GRASSHOPPERS, MITES, SOBBERS, SPIDERS & CENTIPEDES:**

**CONTACT SPRAY:** Spray thoroughly into hiding places such as cracks, crevices, moist areas, open areas around pipes and sinks, under refrigerators, baseboards, and storage areas. Spray directly on insects when possible. Repeat as necessary.

**RESIDUAL SPRAY:** Spray on baseboards, cracks and crevices around door and window frames, other hiding places such as closet back of and under appliances, shelves and cupboards in the kitchen bathroom. In basements, spray hiding places in cracks and crevices, kitchen walls, and dark places. Spray at rate of 3 to 4 seconds per linear foot at a distance of 12 to 24 inches from the surface. Repeat as necessary.

**ANTS:** Apply to ant trails and around door sills, window frames and other places where ants may enter.

**STORAGE AND DISPOSAL STORAGE:** Do not store in direct light. Store at temperatures below 120°F.

**CONTAINER DISPOSAL:** Do not reuse empty container. Replace wrap in paper and discard container in trash. Do not incinerate or puncture.
