

#### To Have Flea-less, Tick-less Dogs and Horses, Follow Instructions Below:

To operate remove protective cap. Hold can upright. Point nozzle in desired direction for spray. Press valve down. Point away from face.

KENNELS. When spraying for flies and ticks around Kennels and Dog Pounds, spray SAFETICIDE BRAND in and around animals sleeping quarters, up the walls and all over the floors. In spraying for clothes moths, treatment should include spraying of the clothing, clothing receptacles every 30 days unless clothing is stored in moth-proof containers. When spraying for clothes moths and carpet beetles, pay particular attention to seams and folds. In spraying for bedbugs, treatment should include spraying of bed, mattresses and hiding places. Repeat weekly to help prevent insects from multifplying.
