

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC
ANIMALS CAUTION**

DIRECTIONS. For use in Rooms, Apartments, Homes, Attics, Basements, Campers, etc. Garages, Pet Sleeping Areas, Household Storage Areas, Closets, Motels, Schools, Washrooms, Hotels, and non-food areas of Industrial Plants and Institutions.

Cover exposed foods, dishes and food handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 4800 cubic feet of unobstructed area. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

TO OPERATE VALVE: To lock valve in open position for automatic discharge, press valve tab all the way down, hooking the catch. Then place fogger on stand or table in center of room, with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for four hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

The spray mist will kill Houseflies, Mosquitoes, Small Flying Moths, Black Carpet Beetles, Spiders, Centipedes, Crickets, Silverfish, Firebrats, Bees, Wasps, Hornets, Fleas, Ticks, and Ants. Aids in control of cockroaches and waterbugs. For fleas and ticks apply at a rate of one can per 1000 cubic feet of area to be treated.
