### Stops rotdecay







### **HOW TO USE**



Use to preserve wood in both old and new structures. Best results are obtained by immersing wood in this solution at the rate of 5 minutes per inch of thickness. Be sure to soak ends of lumber after cutting or fitting. Where immersion is not practical, as in existing construction. two applications are recommended by brushing or flood spraying.

FENCE POSTS should be barked and seasoned thoroughly. Soak in vertical position with butts downward for 24 hours or longer. Full length treatment is recommended.

### Soil poisoninc for termite control



Remove soil from around building leaving a trench 12 inches deep. Soak soil with solution using 1 gal-Ion per 2 cubic feet or 1 gallon per 2 lineal feet of trench. For buildings with deep foundations, a 30 inch deep trench is recommended and solution applied at rate of 1 gallon per lineal foot. Do not spray solution on any part of plants. Grass. plants, and other shrubbery within three feet of trench should be removed or protected. Trench should not be dug below top of footing.

### FIRST AID TREATMENT

### **KEEP CONTAINER CLOSED WHEN NOT IN USE KEEP OUT OF REACH OF CHILDREN**

USE: A 5% penta wood preservative to stop rot and decay in unfinished wood... fenceposts, frames, sub floors, sills, joists, etc. Kills termites and other destructive wood boring insects. See side panels for additional information.

DIRECTIONS: All cutting should be completed before application. Wood must be clean, dry, and free from previous finishes. For best results wood should be completely immersed. An immersion period of 5 min, per inch of thickness is recommended, Liberal brush application or flood spray can be used if immersion is not practical.

COVERAGE: Varies by species and condition of wood. For general use of a 5<sup>3</sup>/<sub>2</sub> penta solution, estimate 150 to 200 sq. ft. per gal for brush application, 5 to 10 gal. per thou sand board feet for immersion treatment.

SPECIAL NOTE: We recommend Seal Treat where a water repellent, clear, and paint able penta wood preservative is desired.
