It works most efficiently in closed areas and places that remain that way for long periods of time such as closets, cabinets, storage containers and cabinets, pantries, coolers, and vehicles in storage. The effectiveness of FG2 will be compromised in well ventilated spaces. Do not use this product in moving vehicles.

{Hanging Moisture Absorbers:}

[Remove from carton and discard clear plastic wrapper. Unfold and hang with enough space to allow air circulation. Replace when all the white crystals have dissolved.]

{Disposable Moisture Absorber:}

[Remove lid and peel off foil cover leaving white safety cover in place. Replace grill lid. Place on a flat surface in the desired location. Crystals will harden and dissolve in up to 45 days.]

{Refillable Moisture Absorbers and Moisture Absorber Refill:}

[Remove lid. Open bag by tearing or cutting. Pour crystals into canister. Replace lid. Place on a flat surface in the desired location. Crystals will harden and dissolve as they absorb moisture.]

[Open refill bag by tearing or cutting. Shake refill bag while holding closed before pouring. Pour crystals into refillable container filling 1" from top. Reclose bag.]

STORAGE AND DISPOSAL:

Store at room temperature. Do not puncture or remove calcium chloride crystals from containers or packaging except to refill container.

Refillable container. During use and over time the FG2 crystals will dissolve and leave water/brine/liquid in the bottom of the container. When the liquid reaches the full line, open the lid of the container and pour the liquid into the toilet. Remove the top of the container, remove the used packs, discard the used packs in the trash and [replace][refill] with [fresh][new] refill packs (see Directions For Use, above). Rinse the drain port before refilling to reduce the potential for clogging.

Non-refillable containers and hanging bags: Do not reuse these containers. Do not recycle. When all the white crystals are dissolved, discard upright in trash.

In case of spills caused by puncture or damage to the product or container:

Hard surfaces - Wipe up spill with a damp towel. Discard spilled crystals in toilet. Wash towel before reusing.

Carpets - Dry spill as much as possible with a damp towel. Wet spill with cool water and press dry with a dry towel. Repeating as necessary to removed spilled crystals. Discard spill crystals in toilet. Wash towel before reusing.

Do not allow collected liquid to contact leather or metal.

Ice-like crystals that may form in the collection chamber or bag should not be disturbed.

Do not remove liquid from container except to dispose of as directed.
