- c. Your beneficial insect warning is noted in the environmental hazards block. Considering the use pattern of this product this warning is not necessary and you have the option of deleting it from the label.

**HOW TO USE DRY FLY KILLER:**

**DRY BAIT:** Dry Fly Killer is ready-to-pour or shake from can.

**SYRUP BAIT:** Dissolve contents of Dry Fly Killer Container (1 pound) in 1 pint (2 cupfuls) of water. Apply on surfaces where flies congregate with paint or calcimine brush.

**DIRECTIONS FOR APPLICATION:** Dairy Barns, Milksheds, Stables, Livestock Barns, Loafing Sheds, Pig Pens and Outdoor areas.

Scatter dry bait at rate of  $\frac{1}{2}$  pound per 1000 square feet on ground or other areas where flies congregate. Ideal baiting sites are around garbage cans, doorways, feedrooms, alleyways and window sills. On freshly limed floors scatter dry bait on paper or clean feed sacks.

Brush freshly prepared syrup bait on outer surfaces on animal enclosures, supporting posts, rafters and along ceiling cracks. Use at rate of 1 to 3 gallons per 1000 square feet. For most effective control repeat as often as necessary, using both dry bait and syrup bait application.

**USAGE CAUTIONS**

Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

This product is toxic to fish and wildlife, also birds. Do not contaminate water by cleaning of equipment or disposal of wastes.

Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in a safe place.
