Dear Ms. Rushton,

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

- Update First Aid Statements per PR Notice 2001-1

**Conditions**

Revise the label as follows:

1. Qualify "bathroom tiles" as hard nonporous surfaces by stating "glazed" bathroom tiles.
2. Under "Fungicidal Activity" revise the phrase, hard surface, by stating hard "nonporous" surface. Also, add the statement, "Follow disinfection directions."
3. Revise the "Precautionary Statements" to reflect the appropriate language assigned to "Warning" products by stating "*Causes substantial but temporary eye injury and skin irritation. Do not get in eyes, on skin, or on clothing. Wear protective eyewear, clothing, and rubber gloves. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse.*"
4. The "First Aid" statements must be reorganized so that the most severest route which is established by the must appear first. Therefore, the statements must appear as follows: If in eyes, If on skin or on clothing, If swallowed, and If Inhaled."

5. The "Storage and Disposal" statement must be reorganized as follows:



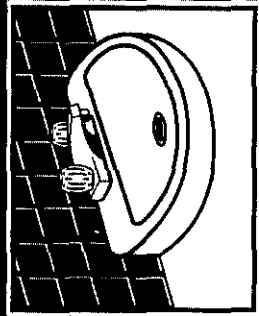

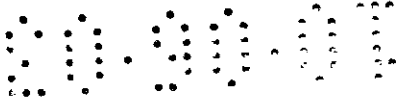

USE:



This product demonstrates effective disinfection against Staphylococcus aureus, Salmonella choleraesuis and Pseudomonas aeruginosa. This product is designed for general cleaning, deodorizing and disinfecting in Nursing Homes, Hospitals and Institutions. When used as directed, it is formulated to disinfect the following inanimate, environmental, hard, non porous surfaces: walls, sinks, tables, shower stalls, bathtubs, hampers. This cleaner also deodorizes areas which are generally hard to keep fresh smelling such as garbage storage areas, basements, restroom (not for use inside toilet bowls), and other areas which are prone to odors caused by microorganisms.

**DIRECTIONS FOR USE:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. **DISINFECTION, CLEANING, AND DEODORIZING:** To disinfect, clean and deodorize hard, nonporous, environmental surfaces such as bathroom tiles, shower stalls, walls, sinks, and bathtubs: 1. Hold container six to eight inches from surface to be treated. 2. Spray area until it is covered with the solution. Allow the product to penetrate and remain wet for 10 minutes. No scrubbing necessary. 3. Wipe off with a clean cloth, mop, or sponge. For heavily soiled areas, remove gross soil before treatment. Let air dry. Repeat application at weekly intervals or when mildew growth reappears. **VIRUCIDAL PERFORMANCE:** This product was evaluated and found to be effective against Herpes Simplex Type 2 on pre-cleaned, hard, nonporous, inanimate, environmental surfaces at a 10 minute contact time. **FUNGICIDAL ACTIVITY:** This product is fungicidal against the pathogenic fungi, Trichophyton mentagrophytes (Athlete's Foot Fungus), when used as directed on hard surfaces found in bathrooms, shower stalls, and locker rooms.
