DIRECTIONS FOR USE

Use as a spot treatment on localized surface areas only.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. To operate: Holding can upright, onifice directed toward surface to be treated, press actuator button.

To kill: cockroaches, spiders, ants, earwigs, crickets, silverfish, spray areas where these pests are found or may hide including dark corners of rooms and closets, cracks and crevices, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry.

To control: flies and mosquitoes, use only on outdoor surfaces. Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions and in garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes. This insecticide provides flushing action and fast knock-down. Controls cockroaches, ants, silverfish, spiders, crickets, earwigs and brown dog ticks.

PRECAUTIONARY STATEMENTS Hazards to Humans and Domestic Animals

CAUTION

Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray air in rooms or use on plants. Apply as a surface spray only as specified on this label. Do not allow spray to contact feed, foodstuffs or water supplies. Thoroughly wash dishes and food handling utensils contaminated with this product. Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Remove pets and cover fish bowls before spraying. Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED—Do not induce vomiting. Contains petroleum distillate. Call a physician immediately. IF INHALED—Remove victim to fresh air. Apply artificial respiration if indicated.
