## Directions for Use

If in a situation of infestation use this product in a narrow streamer with its lance.

Spray infested surface until wet.

**ROACHES, ANTS, SILVERFISH, SPIDERS, CRICKETS:** Spray heavily into cracks, around baseboards and other places where they hide. Also behind and beneath kitchen, refrigerator, sink, stove, etc. Spray other localized areas infested with the pests. Repeat treatment as required.

**CARPET BEETLES:** Place localized application on the floor and baseboards. Spray directly into cracks, closets and infested areas of wallings. Repeat as necessary.

**BROWN DOG FLEAS:** Thoroughly spray infested areas around baseboards, window and door frames, wall coverings. Application should be repeated as necessary. Fresh linens should be placed on and not in contact with treated area. DO NOT wash or dry linens until 24 hours after treatment.

**PERMETHRIN:** Thoroughly spray all areas where the insects are found. Use only as an aid in reducing or eradicating infestation. Do not use on surfaces of treated areas. Do not use on children's clothing. Do not use on food or food containers. Do not use on furniture or other household items. Do not use on plants or animals.
