The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended, is acceptable provided that you make the labeling change indicated below before you release the product for shipment bearing the amended labeling:

In the Directions for Use section, in the paragraph beginning "TO KILL: Fleas and Brown Dog Ticks", revise the phrase, "pets must be treated simultaneously with an E.P.A. approved insecticide" to "pets must be treated simultaneously with an E.P.A. registered insecticide."

Submit five (5) copies of your final printed labeling before you release the product for shipment.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. For control of insects in institutions, food processing plants, restaurants, food handling establishments, industry, schools, motels, and hotels **SHAKE WELL BEFORE USING.** To operate hold can upright, direct orifice toward the surface to be treated and press the actuator button. Do not use as a space spray.

TO KILL: Ants, carpet beetles, centipedes, cockroaches, crickets, earwigs, firebrats, pillbugs, silverfish, and spiders; thoroughly apply as a spot treatment to areas where these pests are found or may hide. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests, and points of entry.

TO KILL: Fleas and Brown Dog Ticks, indoors: Clean premises thoroughly before treatment. Spray an inconspicuous area to check for possible staining or discoloration. Spray the entire floor and carpet area. Also treat animal sleeping quarters. In animal sleeping quarters, bedding should be cleaned or replaced with fresh bedding. Do not use in nurseries or any area where infants may sleep. **DO NOT TREAT ANIMALS WITH THIS FORMULATION.** To avoid reinfestation, pets must be treated simultaneously with an E.P.A. approved insecticide labeled for use on animals. Avoid contact with treated surfaces until they are dry.

TO CONTROL: Flies, Gnats, Hornets, Mosquitoes, Small Flying Moths, Wasps, and Yellow Jackets; use only on outdoor surfaces. Flies and Mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

APPLICATION OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A SPOT AND/OR CRACK AND CREVICE TREATMENT IS NOT PERMITTED.

Use as a crack and crevice treatment in and around both food and non-food areas to control ants, cockroaches, crickets, silverfish, spiders, and waterbugs. Apply as a spot treatment to selective surfaces, such as baseboards, under elements of construction and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.) Do not use this product in conduits, motor housings, junction or switch boxes because of possible shock hazard. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food and food processing surfaces.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION

Harmful if swallowed. Keep out of reach of children. Avoid breathing spray mist. Avoid skin and eye contact. Wash thoroughly after handling and before eating or smoking. Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray air in rooms or use on plants. Apply as a surface spray only. Do not allow spray to contact food, feedstuffs, or water supplies. Do not use in food serving areas while facility is in operation or food is exposed. Thoroughly wash dishes and food handling utensils contaminated with this product. Remove pets and cover fish bowls before spraying.

STATEMENT OF PRACTICAL TREATMENT

SKIN: Remove contaminated clothing and wash affected areas with soap and water. **EYES:** Flush eyes with plenty of water. Call a physician if irritation persists. **INHALED:** Remove victim to fresh air. Apply artificial respiration if indicated. **IF SWALLOWED:** Call a physician or Poison Control Center immediately. Drink one or two glasses of water and induce vomiting by touching the back of throat with finger. Repeat until vomit is clear. Do not induce vomiting or give anything by mouth to an unconscious person.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 120°F may cause bursting.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds, and other wildlife. Do not apply directly to lakes, streams, or ponds. Do not contaminate water when disposing of equipment wash waters. Apply this product only as specified on this label.

STORAGE AND DISPOSAL

STORAGE: Store in original container in a cool dry place inaccessible to children and pets. Do not transport or store below 32°F. **DISPOSAL:** Wrap container in several layers of newspaper and dispose of in trash. Do not puncture or incinerate.
