DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. BTC® 885 Neutral Disinfectant Cleaner-32 is a phosphate-free formulation designed to provide effective cleaning, deodorizing, and disinfection specifically for hospitals, nursing homes, schools, and other institutions where housekeeping is of prime importance in controlling cross-contamination from treated surfaces.

This product, when used as directed, is formulated to disinfect inanimate hard non porous surfaces such as walls, floors, sink tops, toilet bowls, tables, chairs, telephones, and bed frames. For larger areas such as operating rooms, patient care facilities, and restrooms, this product is designed to provide both general cleaning and disinfecting.

This product deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls, and other areas which are prone to odors caused by microorganisms.

DISINFECTION - To disinfect inanimate, hard non porous surfaces add 4 ounces of this product per gallon of water. Apply solution with a mop, cloth, sponge, or hand-pump trigger sprayer so as to wet all surfaces thoroughly. Allow to remain wet for 10 minutes, then remove excess liquid.
