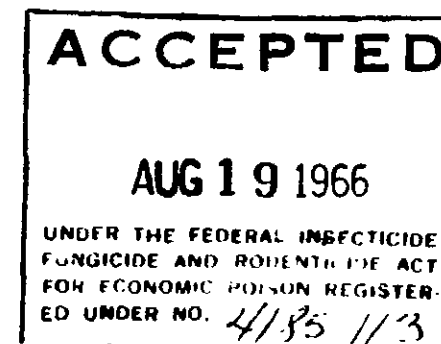

DIRECTIONS FOR USE

FOR MANUFACTURING USE ONLY. Smith-Douglass 4 lb. Aldrin Oil Solution is specially prepared for mixing with fertilizers for soil applications to control certain soil-borne insects. In this way a fertilizer and an insecticide may be applied in a single application.

Manufacturers of fertilizers containing this material should use mineral type fertilizers and those found to be stable with Aldrin as long as the product remains in the channels of trade. Observe all cautions in handling or formulating. Formulated products should be used only for those purposes for which aldrin-fertilizer mixtures have been found suitable. They should be applied to food crops only when the proposed use has been found to leave no objectionable residues at harvest.
