## **DIRECTIONS FOR USE**

TERMITE CONTROL: Remove all scrap lumber and wood chips from under building. Where depth of foundation permits, without endangering footing of same, dig a trench along inside of foundation exposing its surface, approximately one foot wide and ten inches deep. Using a conventional garden watering can, dilute the Chlordane Emulsion at the rate of 14 oz. to 2½ gal. of water. FOUNDATIONS 15" - 18" deep — Apply this material evenly in the trench, using two gal. of the diluted product per five lineal feet as a trenching material. FOUNDATIONS deeper than 18" but not over 30" — Apply four gal. per five lineal feet of trench.


For buildings lacking enough clearance for trenching, it is suggested that a strong light be carried under the building in order that the tunnels built by the termites can be located. When located, destroy them, and using a hand trowel, dig a small trench on both sides of the tunnel location about six inches deep and pour in some of the above mentioned diluted material. Trenching on the outside of the footing is recommended as a measure to prevent re-infestation.

HOUSEHOLD APPLICATIONS: Smith-Douglass Chlordane 75% Emulsifiable Concentrate can be districted as directed below and sprayed as a coarse spray or brushed on cracks or other areas such as window sills, floor moldings, water pipes, and other natural habitats and hiding places of the insect pests. In interior situations, the residual action of this insecticide will protect the treated premises against re-infestation for a period of at least two months. Surfaces exposed to weathering or washings should be treated periodically as needed.



TO CONTROL ROACHES OR WATERBLIGS: Thoroughly treat infested cracks and other hiding places. Apply locally on exposed surfaces where roaches will crawl when they come out of hiding. Repeat treatment when necessary.
