### SUGGESTIONS FOR USE

**IT IS VERY IMPORTANT THAT IT BE UNDERSTOOD THAT THIS FERMATE DUST MUST BE APPLIED BEFORE DISEASE INFECTION OCCURS IN THE PLANTS.**

**FOR TOBACCO PLANT BEDS:** To control Tobacco Blue Mold and Tobacco Flea Beetles in plant beds, apply material with a suitable dust gun without further mixing. Treatment of the plants should begin when the leaves are the size of a dime. Dust twice weekly until transplanting time, making sure that all parts of the bed receive an even and thorough dusting. If rain occurs between regularly scheduled applications, the treatment should be repeated as soon after the rain as practicable.

#### AMOUNT OF DUST REQUIRED TO COVER PLANTS:

- 1st to 4th application—1½ lbs. per 100 square yards
- 5th and 6th applications—2 to 2½ lbs. per 100 square yards
- All other applications—3 to 3½ lbs. per 100 square yards

### WARNING

**IF SWALLOWED OR INHALED:** Do not take internally. Wash eyes, nose, mouth, and skin with plenty of water. Avoid breathing dust. Wear regular long-sleeved work clothes.
