
CHLORDANE 10% GRANULAR



ACTIVE INGREDIENTS:

Technical Chlordane* 10%

Equivalent to 6% Octachloro-4, 7-methanotetrahydroindane & 4% related compounds.

For Control of Soil Insects in Corn (Field and Sweet): Broadcast Application: Make broadcast application of 26 lbs. Chlordane 10% Granular per acre for control of the soil insect complex including wireworms, white grubs, seed corn beetles and white-fringed beetles. For the control of corn rootworms (Western, Southern, Northern) and cutworms, apply 26 pounds of Chlordane 10% Granular per acre. For the control of cornfield ants and cornroot aphids, use 25 lbs. Chlordane 10% Granular per acre. Apply Chlordane after field is plowed. Disc in promptly. Use the higher rate on heavier soils and the lower rate on light sandy soils. Use the higher rates for heavy infestation of cutworms.

Row Application: To control corn rootworms (Western, Southern, Northern), cornfield ants and corn root aphids, apply 10 lbs. Chlordane 10% Granular at planting time in the furrow, behind the planter shoe and ahead of the press wheel. To control wireworms and white grubs, apply 25 pounds Chlordane 10% Granular per acre in the row at planting time. Consult State Agricultural experiment Stations for detailed information.

For Insect Control on Ornamental Turf, Nursery and Greenhouse Soils: For the control of ants, armyworms, boxelder bugs, chinch bug, crickets, European earwigs, grasshoppers, Japanese beetle grubs, mosquitges, rose chafer, sod webworm, spiders, ticks, white-fringed beetle, white grubs and wireworms in Turf (such as Golf Coursee, Atheletic Fields, Large Estate Nurseries, Cemeteries, and Park Sod) and in Nursery and Greenhouse 10% Granular per acre $(4/5 \text{ lb. to each } 1,000 \text{ l$ sq. ft.) to cover surface uniformly using a lawn fertilizer spreader. Treatment should be applied in the Spring or when insects are observed to be troublesome. Do not treat soil when it is wet. Apply before rain or sprinkling. Do not apply to newly seeded areas.

For Insect Control on Home Lawns: For the control of the above listed insects on home lawns, apply 32 lbs. of Chlordane 10% Granular per acre (4/5 lbs. to each 1,000 sq. ft.) to cover surface uniformly using a fertilizer spreader. Treatment should be applied in the Spring, or when insects are observed to be troublesome. Immediately after treatment, drench lawn with water or sprinkle heavily to make treatment more effective and to reduce the hazard to children and pets. Do not treat when soil is wet. Apply before rain or sprinkling. Do not apply to newly seeded areas.

Potato Soil Insects: For control of Japanese beetle larvae, white fringed beetle larvae, white grubs, wireworms, apply 26 lbs. of Chlordane 10% Granular per acre. Make application broadcast prior to or at planting time and work into the top 3 or 4 inches of the soil. Increase dosage 100% on the peat or muck soils. Consult State Agricultural Experiment Stations for additional information, as the rate of application needed will vary with local conditions.

Crabgrass Control: Apply 14 lbs. Chlordane 10% Granular per 1,000 sq. ft. of lawn or turf to suppress crabgrass seedlings as germination or spouting occurs. It is for use as an early season preventive of crabgrass seed establishment. Timing of application is important and should be applied before any germination which in many areas is during the period from April 15 to May 1. Do not apply to newly seeded areas. This treatment will not burn or injure estab-

lished lawns. Spot Treatment: For spot treatment to infested patches, apply in late Winter or early Spring prior to crabgrass seed germination using 1.4 lbs. Chlordane 10% Granular per 100 sq. ft. Helpful Hints: After crabgrass seedlings have been suppressed by the Chlordane treatment, control may be assisted by: 1) Mowing the lawn to $1\frac{1}{2}$ - 2 inches. 2) Using an adequate quantity of fertilizer to maintain active growth. After treatment, drench lawn with water or sprinkle heavily to make treatment more effective and to reduce the hazard to children or pets.

Keep children and pets off treated lawns until Chlordane has been washed into the soil by sprinkling, drenching, or rain and grass has completely
