> a. Revise the heading "Directions" to "Directions for Use", and include the following misuse statement directly below it to read: "It is a violation of federal law to use this product in a manner inconsistent with its labeling."

b. On the right side panel, above the word "Danger", include the following precautionary statements:

c. Revise the heading "First Aid" to "Statement of Practical Treatment".

d. Under "Note to Physician" delete the sentence beginning with "Measures against ciruclatory ... needed."

f. Revise the "Storage and Disposal" statements to read:

Storage and Disposal

Do not contaiminate water, food, or feed by storage or disposal.

Storage: Store in a cool place away from oxidizing or bleaching agents. Use from original container and keep covered when not in use.


