

KEEP OUT OF REACH OF CHILDREN POISON DANGER STATEMENT OF PRACTICAL TREATMENT IF SWALLOWED: CALL A PHYSICIAN OR POISON CONTROL CENTER IMMEDIATELY: If less than ten (10) minutes have passed since the poison was taken, give 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Have patient lie down in quiet, darkened room and keep him warm and quiet. Administer 100% OXYGEN by positive pressure to provide as much pulmonary gas exchange as possible, despite seizures. **B.** Administer ANTICONVULSANT DRUGS intravenously to control convulsions. CAUTION: It may be difficult or impossible to stop the seizure activity without stopping respiration. Be prepared to maintain pulmonary ventilation mechanically. DANGER

Strychnine baits should not be used in the geographic ranges of the following species except under programs and procedures approved by the USEPA: California condor, San Joaquin kit fox, Aleutian Canadian goose, Morro Bay kangaroo rat, gray wolf and grizzly bear.

USE RESTRICTIONS


For underground use against pocket gophers only. BAITING DIRECTIONS

HAND BAITING

Bait must be placed into pocket gopher runways. Remove burrow plug from the flat side of the burrow fan. Use long-handled spoon and insert one teaspoon of bait into main runway system. Close tunnel with soil in such a manner that soil will not cover bait. One pound of bait will treat five to eight acres.

MACHINE BAITING

When treating extensive areas, "BURROW BUILDERS" may be used. Make sure that machinebuilt burrows intersect gopher burrows at the depth at which gophers have been tunneling. For greatest efficiency of treatment, machine-built burrows should intersect as many gopher tunnels as possible at right angles. Machine-bait at a rate of five pounds per acre and at 20' to 25' intervals.



STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store only in original container, in a dry place inaccessible to children, pets and domestic animals.
