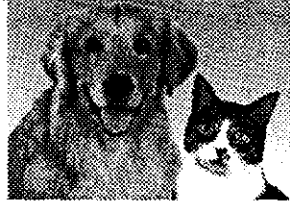

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Wet dog or cat's hair thoroughly with warm water. Starting with the head, rub shampoo into coat. Work backward until coat is completely covered with foamy lather. Allow lather to remain five minutes. Rinse thoroughly and towel dry. Repeat every 2 to 3 days as needed.

It is recommended that pet's bedding or sleeping quarters be treated for flea, tick, lice or chigger control with a product like Scratchex® Flea & Tick Spray.

PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS

WARNING: Causes eye irritation. Do not get in eyes. In case of contact, immediately flush eyes with plenty of water. Get medical attention if irritation persists. Do not use on dogs or cats under 12 weeks of age. Consult a veterinarian before using this product on debilitated, aged, medicated, pregnant or nursing animals. Sensitivities may occur after using any pesticide for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. If undue skin irritation develops or increases, discontinue use and consult a veterinarian. Do not use on severely traumatized or irritated skin.

STORAGE & DISPOSAL

STORAGE: Store in a cool, dry place.
DISPOSAL: Do not reuse empty container. Wrap container and put in trash collection.
