

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Sulfodene® SCRATCHEX® Colorful Flea & Tick Collar for Cats contains chlorpyrifos insecticide, one of the longest lasting flea and tick killers available for use on cats. This collar will reach its maximum effectiveness within 2 to 3 days after placing it on the cat and will continue to protect your cat against fleas for 11 months and ticks for 6 months. Ticks are only occasional and usually temporary pests of cats. Place the collar around cat's neck, buckle and adjust for proper fit. Cut off close to buckle and dispose of excess length. The collar must be worn loosely so that two fingers may be placed between collar and cat's neck. If collar is worn too tightly, it may produce neck imitation. Fleas and ticks present in the cat's environment that may reappear on your pet will be killed by the action of this collar. Collar's effectiveness is not diminished by normal wetting such as rainfall. Use only one collar on an animal at a time.
