Dear Ms. Campbell:

The following amendment, submitted in connection with registration under 3(c)(7)(A) of the Federal Insecticide, Fungicide, Rodenticide Act (FIFRA), as amended, is acceptable with the comments listed below.

Proposed Amendment

- Update First Aid Statements per PR Notice 2001-1

Label Comments

1. Delete the "Self-Sanitizing" claim. Per Agency letter, dated April 12, 1993, this claim is not acceptable. The proposed protocol is not acceptable because it does not meet the criteria specified in the EPA product performance guidelines for the determination of the residual self-sanitizing activity of dried chemical residues on hard, inanimate surfaces. You must submit data to make this claim.
2. Delete the phrase "Tests on floors treated as directed show a reduction of odor causing bacteria levels of 99.999% in environments having greater than 50% relative humidity." This is a sanitizing (public health) claim and you must submit data to support this claim.

- 3. Delete the phrase "Avoid contamination of foods." from the label.
- 4. Place the phrase "Keep from freezing." with the Storage and Disposal Statements.
- 5. The "Note to Physician" under the First Aid Statements should be deleted. It is not required for this product.
- 6. Since this product is sold in 1 gallon containers, you must revise your storage and disposal instructions accordingly:


Storage and Disposal

Store in original container in areas inaccessible to children and persons unfamiliar with its proper use. Keep from freezing. Do not reuse container. Wrap container and discard in the trash.

- 7. Revise the Precautionary Statements to read:
CAUTION. Keep out of Reach of Children. Harmful if absorbed through the skin. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling.

This copolymer finish is designed for use in hospitals, laboratories, nursing homes, institutions, commercial buildings, and households. It contains a chemical ingredient which provides residual bacteriostatic activity against odor-causing bacteria.

Damp mopping activates the bacteriostatic qualities of the floor finish. Tests on floors treated as directed show a reduction of odor-causing bacteria levels of 99.999% in environments having greater than 50% relative humidity.

Its long-lasting shine is remarkably resistant to rubber marking and scuffing. One gallon will cover 2000 to 2500 square feet.

Wet floors may be slippery floors. Clean up all spills right away.

Directions for Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Clean floors thoroughly, rinse and allow to dry before applying first coat of copolymer floor finish.

Use clean applicator. Apply the finish in a thin, uniform coat and allow to dry. A second coat will give an even deeper gloss. To avoid contamination, do not return unused finish to original container.

Sweep or dry mop each day to remove surface dirt. Damp mop with water or dilute solution of neutral cleaner to remove accumulated soil. Buff to brighten.
