

PRECAUTIONARY STATEMENTS Under the Foderal Inst HAZARDS TO HUMANS AND DOMESTIC ANIN Respicide, and Redent

DANGER

Keep Out of Reach of Children. Corrosive. Causes severe eye and skin damage. Do not get in eyes, on skin or on clothing. Protect eyes and skin when handling concentrate. Harmful if swallowed. Avoid contamination of food.

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash all contaminated clothing before reuse. If swallowed, drink milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Call a physician.

NOTE TO PHYSICIAN

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression, and convulsion may be needed.



When used as directed, it will remove most dirt and grime in a single, simple application. Follow the Use Directions. Use on walls, floors, table tops and other hard, nonporous surfaces in industrial plants, offices, motels, schools.

USE DIRECTIONS

To disinfect against Pseudomonas aeruginosa, use 6 oz. per gallon of water.

Clean and disinfect whirlpool equipment using a dilution of 6 oz. per gallon of water. For sanitization of previously cleaned food processing equipment or food contact items, limit the active quaternaries to 200 ppm (8 oz. per 5 gallons water). Rinse with potable water after treatment.

USE DIRECTIONS

DISINFECTION: For heavy duty cleaning and disinfecting and fungicidal activity against pathogenic fungi, use 4.5 oz. per galion of water. For best results, use a cloth or mop and apply to walls, floors, table tops, counters, other non-porous surfaces.

SANITIZATION: For light duty cleaning, sanitizing and deodorizing, use 2 oz. per gallon of water. If used for sanitization of previously cleaned food contact items, limit the level to 200 ppm of quaternaries, (8 oz. per 5 gal. water). Rinse with potable water after treatment.

For extra heavy industrial cleaning a disanitizing, use a second application. Do not mix with soap or anionic solutions. This product is non-corrosive in use dilutions on inanimate hard surfaces.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Do not reuse empty container. Triple rinse and disnose in an incinerator or landfill approved for pesticide containers, or bury in a safe place. Pesticide, spray mixture, or rinsate that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies.
