 MOU Compliance Amendment dated December 23, 1994

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes listed below before you release the product for shipping bearing the amended label.

1. Under the Statement of Practical Treatment, revise the statement "If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution..." to read, "If swallowed, drink promptly a large quantity of water."
2. Within the paragraph beginning "To disinfect against Pseudomonas aeruginosa..." add the minimum contact time of 10 minutes, and the method for removing the product after the contact time (e.g. wipe with a clean cloth, allow to air dry, etc.).

A stamped copy of the labeling is enclosed for your records. Submit 5 copies of the final label prior to releasing the product for marketing.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

This is a heavy duty cleaner and disinfectant designed for general purpose use where heavy duty cleaning is of prime importance. When used as directed, it will remove most dirt and grime in a single, simple application. Follow the Use Directions. Use on walls, floors, table tops and other hard, nonporous surfaces in industrial plants, offices, motels, schools.

To disinfect against Pseudomonas aeruginosa, use 6 ounces per gallon of water or 1 liter (33.8 ounces) per 5 gallons. Clean and disinfect whirlpool equipment using a dilution of 6 ounces per gallon of water.

DISINFECTION: For heavy duty cleaning and disinfecting and fungicidal activity against pathogenic fungi, use 4.5 ounces per gallon of water. For best results, use a cloth or mop and apply to walls, floors, table tops, counters, other nonporous surfaces. Thoroughly wet all surfaces. Allow to remain wet for ten minutes and then let air dry.

For light duty cleaning and deodorizing, use 2 ounces per gallon of water. For extra heavy industrial cleaning, use a second application. Do not mix with soap or anionic solutions. This product is noncorrosive in use dilutions on inanimate hard surfaces.

This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to preclean or decontaminate critical or semi-critical medical devices prior to sterilization or high level disinfection.

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

DANGER: Keep Out of Reach of Children. Corrosive. Causes severe eye and skin damage. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful if swallowed. Avoid contamination of food.

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash all contaminated clothing before reuse. If swallowed, drink egg white, gelatin solution, or if these are not available, drink large quantities of water. Call a physician.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.

STORAGE AND DISPOSAL

DO NOT CONTAMINATE WATER, FOOD, OR FEED BY STORAGE OR DISPOSAL.

STORAGE: Keep container closed when not in use. Do not store near heat or open flame. **PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **CONTAINER DISPOSAL:** Plastic Containers—Triple rinse (or equivalent). Then offer for recycling or reconditioning, or pure and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
