Dear Ms. Campbell:

The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with comment.

Proposed Amendment

- Revised labeling in response to Agency letter dated May 30, 2002

General Comments

The Agency has asked registrants to begin submitting "Master" labels which contain all the claims, use sites, directions, storage/disposal statements, and environmental hazard statements on one label. Your product label for 5 gallon containers was stamped instead of the 1 gallon container label because it was determined to be a master label. You should revise your label to bring it into compliance with the above criteria for a "master" label. Your label will need to have two environmental hazards sections, one would support the language on the approved label with the phrase, (for containers 5 gallons or more only) beside the heading. A second "Environmental hazards" section will need to be added for containers 5 gallons or less which contain the statement, "This pesticide is toxic to fish."

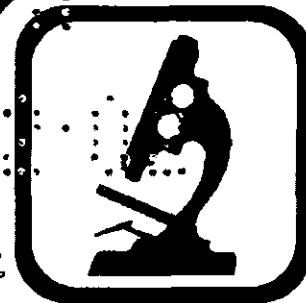

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling. This disinfectant makes a bright, clear solution when mixed with water. Do not mix with soap or other detergents. Use in hotels, motels, schools, public buildings. This product should not be used on surfaces which will come in contact with food unless the surface is thoroughly scrubbed with detergent and rinsed with potable water prior to reuse.

Remove gross filth from surfaces prior to disinfection. Use 2 oz. of this product per gallon of water to kill Staphylococcus aureus and Salmonella choleraesuis on toilet seats or exterior of bowl surfaces, shower stalls, refrigerator exteriors, diaper pails, garbage cans, and restroom floors. Apply solution with mop, sponge, or cloth and keep the hard, non-porous surfaces wet for at least 10 minutes. Allow to air dry. If the product contacts food contact surfaces such as kitchen counters and tables, thoroughly rinse surfaces with potable water. Do not use on glasses, dishes, or silverware.

Use 1 oz. of this product per gallon of water for deodorizing. Apply solution with cloth, mop, or spray.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS & DOMESTIC ANIMALS

DANGER: CORROSIVE. Causes irreversible eye damage and skin burns. Do not get in eyes, on skin, or on clothing. Wear protective eye wear (goggles or faceshield), protective clothing, and rubber gloves. Harmful if swallowed or absorbed through the skin. Wash thoroughly with soap and water after handling. Remove contaminated clothing before reuse.

FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Have the product container or label with you when calling a poison control center or doctor or going for treatment. **NOTE TO PHYSICIAN:** Probable mucosal damage may contraindicate the use of gastric lavage.

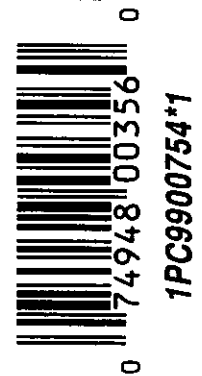
ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.

STORAGE AND DISPOSAL

DO NOT CONTAMINATE WATER, FOOD, OR FEED BY STORAGE OR DISPOSAL. STORAGE: Keep container closed when not in use.
