e. Since your data matrix does not provide a dielectrical breakdown voltage, you must add the following statement to the Physical or Chemical Hazard section:

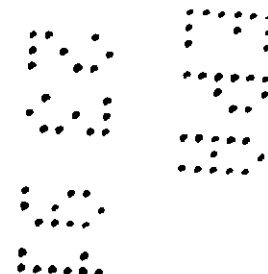

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Harmful if swallowed or inhaled. Contains petroleum distillate. Do not induce vomiting because of aspiration pneumonia hazard. Causes moderate eye injury. Avoid breathing vapors or spray mist. Avoid contact with skin or eyes. In case of contact, flush with plenty of water. Wash with plenty of soap and warm water after use. Obtain medical attention if irritation persists. Avoid contamination of food and feedstuffs.

Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed.

Remove pets, birds, and cover fish aquariums before spraying.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Keep away from heat, sparks, and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130 F may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product will kill cockroaches, confused flour beetles, crickets, fleas, houseflies, pill bugs, rice weevils, saw-toothed grain beetles, silverfish, small flying moths, spiders, ticks and wasps.

Never exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and turn off pilot lights. Close doors and windows. Point valve opening away from face when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

TO OPERATE VALVE: Place several layers of newspaper or pad on stand or on table in the center of the room. Point valve opening away from face. To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place fogger on stand or table with valve locked open. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for 10 minutes. Repeat spraying in two weeks or when necessary.

1 - 1 AVAILABLE

To Kill Ticks and Fleas: Destroy pet's old bedding and replace with clean, fresh bedding after treatment is completed. Use product as above. Pets should be treated with a registered flea and tick control product prior to reentering treated premises.

STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area away from heat or open flame.

DISPOSAL: Replace cap and discard container in trash. Do not incinerate or puncture.
