Hazards To Humans & Domestic Animals

CAUTION

Harmful if swallowed. Keep out of reach of children. Avoid breathing spray mist. Avoid skin and eye contact. Wash thoroughly after handling and before eating or smoking. Do not allow children or pets to contact treated surfaces until spray has dried.

Do not spray air in rooms or use on plants. Apply as a surface spray only.

Do not allow spray to contact food, feedstuffs or water supplies. Do not use in food serving areas while facility is in operation or food is exposed. Thoroughly wash dishes and food handling utensils contaminated with this product.

Remove pets and cover fish bowls before spraying.

Environmental Hazards

This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water when disposing of equipment washwaters. Apply this product only as specified on this label.

Physical Or Chemical Hazards

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

STORAGE & DISPOSAL

Storage: Store in original container in a cool dry place inaccessible to children and pets. Do not transport or store below 32°F. **Disposal:** Wrap container in several layers of newspaper and dispose of in trash. Do not puncture or incinerate.

To operate hold can upright, direct orifice toward the surface to be treated and press the actuator button. Do not use as a space spray.

SHAKE WELL BEFORE USING

TO KILL ANTS, CARPET BEETLES, CENTIPEDES, COCKROACHES, CRICKETS, EARWIGS, FIREBRATS, PILLBUGS, SILVERFISH AND SPIDERS: thoroughly apply a spot treatment to areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, under carpets, along baseboards and door sills and frames, behind and beneath sinks, stoves, refrigerators, and cabinets, and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry.

TO KILL FLEAS AND BROWN LICE, TICKS INDOORS: Clean premises thoroughly before treatment. Spray an inconspicuous area of furniture, carpet or flooring to check for possible staining or discoloration. Spray the entire floorable carpet area. Special attention should be given to cracks, crevices, and under carpet and rug edges. Also treat animal sleeping quarters, closets, upholstered furniture (with particular attention to seams), under and other furniture, in animal sleeping quarters, bedding

should be cleaned or replaced with fresh bedding. Do not use in nurseries or any area where infants may sleep. DO NOT TREAT ANIMALS WITH THIS FORMULATION.

To avoid reinfestation, pets must be treated simultaneously with an E.P.A. registered insecticide labeled for use on animals. Application should be repeated as necessary. Humans and pets must avoid contact with treated surfaces (rugs, upholstered furniture, etc) until they are dry.

TO CONTROL: Flies, Gnats, Hornets, Mosquitoes, Small Flying Moths, Wasps and Yellow Jackets; use only on outdoor surfaces. Spray outside surfaces of window and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions and in garages where these insects may congregate. **Flies and Mosquitoes** coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

APPLICATION OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A SPOT AND/OR CRACK AND CREVICE TREATMENT IS NOT PERMITTED.

Application within food handling establishments (places other than private residences in which food is held, processed, prepared or served) including, but not limited to, areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing foods, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) and serving areas (Do not use while facility is in operation or food is exposed): Use as a crack and crevice treatment in and around both food and non-food areas to control **Ants, Cockroaches, Crickets, Silverfish, Spiders And Waterbugs**. Apply in small amounts directly into cracks and crevices, in points between different elements of construction, between equipment and floor, openings leading to voids and hollow spaces in walls, equipment legs and bases. Do not use this product in conduits, motor housings, junction or switch boxes because of possible shock hazard. If there is a need to treat such areas, use only oil-base sprays. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food and food processing surfaces.

Application Within Food Serving Areas (facilities where foods are served, such as dining rooms, but excluding areas where foods may be prepared or held): Apply as a spot treatment to selective surfaces, such as baseboards, under elements of construction and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed)
