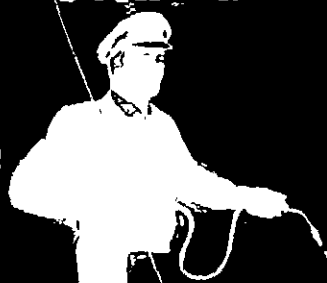

ACTIVE INGREDIENTS: *O*-cis, *trans* Allethrin* (allyl homolog of Chlorin II) 0.480%; Other isomers 0.020%; 3-phenoxybenzyl *O*-cis and *trans*-2,2-dimethyl-3-(2-methyl propenyl)cyclopropanecarboxylate 0.072%, related isomers 0.003%, petroleum distillate 10.000%.

**O*-*trans* isomer ratio: max. 25% (±) *cis* and min. 75% (±) *trans*
INERT INGREDIENTS: 89.425% (Contains 0.100% sodium n-But)

To SPRAY: remove tab on front of spray cap. Look into hole on top of cap and turn cap until white mark appears. After use, turn cap until white mark disappears.

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.
Shake Before Using. Hold container upright. Point spray opening away from face and press button.

HOUSEFLIES, MOSQUITOES, SMALL FLYING MOTHS, GNATS: Most effective when sprayed directly on flies. You can clear entire room in minutes by spraying upwards in sweeping movement (4 seconds for average room of 1000 cubic feet) staying about 3 feet from walls, fabrics and furniture. Keep doors and windows closed for 15 minutes. Do not remain in treated area. Ventilate after treatment.

ROACHES, WATERBUGS, SILVERFISH, CRICKETS: Spray hiding places such as baseboards and doorboards, moist places, openings around sinks, drains and pipes, behind bookcases, cabinets and other storage areas hitting as many insects as possible. Repeat applications as necessary.

ANTS: Spray trails, hills, around windows and sills and openings around pipes and baseboards where ants crawl hitting as many as possible. Repeat applications as necessary.

DISPOSAL

Do not reuse empty container, wrap container and put in trash collection.

PRECAUTIONARY STATEMENTS

HAZARD TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if swallowed or absorbed through skin. Avoid breathing vapors. Avoid contact with eyes, skin or clothing. In case of contact, immediately flush eyes and skin with plenty of water. Get medical attention if irritation persists.

Do not remain in enclosed areas after use. Ventilate enclosed areas before returning. Avoid contamination of food and foodstuffs. Remove pets, birds, and cover fish aquariums before spraying.
