

DIRECTIONS

A pressurized surface spray for control of crawling insects like roaches, ants, spiders and carpet beetles, or such flying insects as flies, mosquitoes and wasps.

ROACHES, ANTS, WATERBUGS, SILVERFISH, CRICKETS: Spray heavily into all cracks, around baseboards, and other places these insects hide. Also spray, until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and on baseboards. Spray other localized areas infested with these pests. Repeat as necessary.

CARPET BEETLES: Make localized applications to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks, closets and infested areas of shelving. Repeat as necessary.

FLIES, MOSQUITOES, WASPS, AND FLYING MOTHS - OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

DIRECTIONS

SPIDERS: Spray heavily into all cracks, around baseboards, and other places these insects hide. Also spray, until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and on baseboards. Spray other localized areas infested with these pests. Repeat as necessary.
