**PRECAUTIONARY STATEMENTS  
HAZARD TO HUMANS AND DOMESTIC ANIMALS**

**Corrosive.** Causes irreversible eye damage and skin burns. Do not get in eyes, on skin, or on clothing. May be fatal if swallowed, absorbed through the skin, or inhaled. **Hydraulic Fracturing [Not for Use in California]**

DV10113 should be added to the frac water storage tanks or directly into the well head injection pipeline as the water is being pumped down-hole. Add 100-600 ppm of DV10113 (44-262 ppm THPS), depending on the degree of bacterial fouling in the source water.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Store this product in a cool, dry area away from direct sunlight and heat to avoid deterioration. In case of a spill, flood the area with large quantities of water.

**PESTICIDE DISPOSAL:** Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. **CONTAINER HANDLING AND DISPOSAL: Nonrefillable container [greater than 5 gallons].** Do not reuse or refill this container. Offer for recycling or reconditioning if appropriate. Triple rinse or pressure rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.
