Supplemental Labeling for Leafy Greens  
Your Submissions of December 12, 1995

The amendments referred to above, submitted in connection with registration under FIFRA sec. 3(c)(7)(A), are acceptable provided that you:

1. Revise the supplemental labeling for turnip tops by changing the first word under Directions from "begin" to "apply". Begin implies that there may be repeated applications.

2. Revise the basic product label to incorporate the uses on the supplemental labeling at the next label printing.


3. Do not release the supplemental labeling until entry by the Administrative Law Judge of the Accelerated Decision and Order canceling all other uses of EBDCs on collards, mustard greens, spinach and turnips.

4. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of each supplemental label is enclosed for your records.

Turnip Tops	Alternaria Leaf Spot Cercospora Leaf Spot Downy Mildew	1.5	Begin when disease threatens. Do not use more than 1.5 lbs (1.2 lbs a.i.) per cutting. Do not apply within 14 days of harvest.
