Dear Mr. Formella:

The Agency has completed its review of the five acute toxicity studies that were submitted in connection with the registration of the subject product under the Federal Insecticide, Fungicide and Rodenticide Act as amended. These studies have been found to be acceptable. A copy of the Agency's Technical Review Memorandum dated March 28, 2003 is enclosed for your records.

The Technical Review Memorandum noted that verification of the study cited by you to fulfill the dermal sensitization requirement was only done over the phone by the Fungicide Branch. You must confirm in writing that you are citing MRID 41643003 to fulfill this requirement.

The subject labeling submitted in accordance with the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made to the label:

1. FIRST AID: It is suggested that you add a HOTLINE number for emergency medical treatment information.

2. PRECAUTIONARY STATEMENTS:

- Add the following sentences to the first paragraph: "Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Remove contaminated clothing and wash clothing before reuse."
- Under PERSONAL PROTECTIVE EQUIPMENT, change "Waterproof gloves" to "Chemical resistant gloves made of any waterproof material."
- Under HANDLER SAFETY RECOMMENDATIONS, add the following sentence: "Wash thoroughly with soap and water after handling."

- Pesticide Disposal Instructions: change this subheader to "Pesticide Disposal"
