

GENERAL INFORMATION

ACCELERATE is a liquid concentrate that when tank mixed with sodium chlorate type (containing suitable fire suppressants) or organic phosphate cotton defoliants causes a fasier and more dependable leaf drop prior to hand picking or machine harvesting. The combination of ACCELERATE and sodium chlorate type or organic phosphate defoliants usually 'drops leaves in a green condition in approximately one-half the time of sodium chlorate type or organic phosphate defoliants without ACCELERATE. Under favorable defoliation conditions, satisfactory leaf drop will require 3-4 days; whereas, under adverse conditions, such as low temperatures, toughened plants or actively growing plants, it may be extended to 6-7 days. ACCELERATE is non-corrosive to metal and will not damage metal parts normally used in applying spray chemicals. Recommended rates of ACCELERATE used alone without sodium chlorate type or organic phosphate defoliants will not give satisfactory defoliation. Wash out sprayer immediately after use. Do not apply this product through any type of irrigation system.

Inder normal conditions, apply the combination of ACCELERATE and sodium chlorate type or organic phosphate defoliants when fiber quality of the top bolls will not be damaged by loss of the top leaves which feed these bolls (top bolls should be firm to thumb pressure or difficult to cut with a sharp knife). The combination of ACCELERATE and sodium chlorate type or organic phosphate defoliants will not lamage the bolls directly or cause them to open prematurely. Ground machines should have at least 3 nozzles per row including one overhead nozzle and have pressure and speed adjusted to give fine troplets yet maintain the correct spray volume of 15 to 25 gallons per acre. For aerial application ates of 5-12 gallons of total spray should be used. Aerial applicators should fly as closely as possible of the plant tops and avoid application during the excessive temperatures of midday and when winds have cause drift to adjacent fields. If spraying is interrupted, be cure to start agitation before suraying s resumed.

Apply specified spray dosage per acre in recommended gallons of water to give thorough coverage to nature cotton when 50% or more of bolls are open. Applications can be made until frest.

APPLICATION RATES

Observe all cautions and limitations on labeling of all products used in mixtures.

ACCELERATE WITH ORGANIC PHOSPHATE DEFOLIANTS:

Under ideal defoliation conditions, tank mix with water 1 pint of organic phosphate defoliant with 1 pints of ACCELERATE per acre. Under adverse defoliation conditions, use 1½ pints of ACCELERA with an increased rate, up to the maximum label rate, of organic phosphate defoliant. Always a ACCELERATE to organic phosphate defoliants previously tank mixed with water. Do not mix togeth without water. Be sure mixing tank is clean because residues of insecticides may cause curdling.

ACCELERATE WITH SODIUM CHLORATE TYPE DEFOLIANTS:

Under ideal defoliation conditions, tank mix 1 pint of ACCELERATE with label recommended rate sodium chlorate type defoliants per acre. Under adverse defoliation conditions, increase rate ACCELERATE to 11/2 pints per acre.

COMPATIBILITY: ACCELERATE Cotton Harvest Aid is compatible with Arsenic Acid, Bolls-Eye Cyclone®, DEF®, Dropp®, Folex®, Harvade®, Paraguat, Prep®, Sodium Chlorate, and Starfire®, and me applied in sequence or as a tank mixture. Good agitation in the Spray tank is essential and a tank mixture should not be allowed to stand without agitation for more than 5 to 10 minutes. ACCELERA should be added last to avoid excessive foaming. Read and observe all appropriate label use directions and precautions for the defoliants used.
