Remove scale, pesticide residues, and other foreign matter from the chemical tank and entire injector system. Flush with clean water

Prepare a suspension of MANEB PLUS ZINC F4 in a mix tank. Fill the tank with 1/2 or 1/4 the desired amount of water. Start mechanical or hydraulic agitation. Slowly add the required amount of MANEB PLUS ZINC F4 and then the remaining volume of water

Set sprinkler system to deliver 0.1 to 1.25 inches of water per acre. Volumes of water higher than this may reduce efficacy.
