## CHEMIGATION NOT FOR THIS USE IN CALIFORNIA GENERAL INSTRUCTIONS

Apply this product only through sprinkler irrigation systems including center pivot, lateral move, end tow, side (wheel) roff, traveler, big gun, solid set, or hand move. Do not apply this product through any other type of irrigation system.

Crop injury, tack of effectiveness, or illegal pesticide residues in the crop can result from nonuniform distribution of treated water.

If you have any questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other expents.

A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

Do not connect chemigation system to any public water system. Public water system means a system for the provision of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.

#### SYSTEM REQUIREMENTS

Systems utilizing a pressurized water and pesticide injection system must meet the following requirements:

The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from back-flow.

The pesticide injection pipel-ne must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. The pesticide injection pipeline must also contain a functional normally closed solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply fank when the irrigation system is either automatically or manually shut down.

The system must contain functional interlocking controls to automatically shul off the pesticide injection pump when the water pump motor stops.

The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with peslocides and capable of being fitted with a system interlock.

#### INSTRUCTIONS FOR SPRINKLER (OVERHEAD) IRRIGATION:

Observe the requirements in the System Requirements section above.

Do not apply when wind speed favors drift beyond the area intended for treatment.

Apply MANER PLUS ZINC F4 only through systems containing anti-syphon and check valves designed to prevent water source contamination or overflow of the mix tank and containing inter-locking controls between the metering device and the water pump to insure simultaneous shuf-off. Maintain a gentle continuous agitation in mix tank during mixing and application to assure a

uniform syspension.

Greater accuracy in calibration and distribution will be achieved by injecting a larger volume of a more dilute suspension per unit time.

Application of more than recommended quantities of irrigation water per acre may result in decreased product performance.

Do not apply when wind speed tavors drift, when system connections or fittings leak, when nozzles do not provide uniform distribution or when lines containing the product cannot be flushed and must be dismantled and drained. In a center pivot system, block the nozzle set nearest the well/pivot/injection unit to prevent spray being applied to this area.

Where sprinkler distribution patterns do not overlap sufficiently, unacceptable disease control may result

Allow sufficient time for pesticide to be flushed through all lines and all nozzles before turning off irrigation water.

MANES PLUS ZINC F4 may be applied in conjunction with chemically neutral liquid fertilizers. Application in conjunction with highly alkaline fertilizers, such as aqueous ammonia, may cause a degradation of the pesticide, resulting in reduced performance and should be avoided.

Check local restrictions and requirements regarding sprinkler strigation applications, as they may vary from state to state.

#### SPRAY PREPARATION:

Remove scale, pesticide residues, and other foreign matter from the chemical tank and entire injector system. Flush with clean water.

Prepare a suspension of MANEB PLUS ZINC F4 in a mix tank. Fill the tank with % or % the desired amount of water. Start mechanical or hydrautic agitation. Slowly add the required amount of MANEB PLUS ZINC F4 and then the remaining volume of water.
