Almond Leaf Rust Brown Rot Blossom and Twig Blight Scab Shot-hole Fungus Leaf Blight	6.0 - 8.0 <div>Rate per 100 gal removed</div>	Apply at popcorn, full bloom, and petal fall or every 7 to 10 days if bloom is staggered. Omit petal fall spray if only brown rot is present. Do not apply later than 5 weeks after petal fall or within 145 days of harvest. Do not apply more than 25.6 lbs. active ingredient (32 lbs. product) per acre per season. Do not allow livestock to graze in almond orchards.

Observe all applicable precautions and limitations on the Federal label. This label and the Federally registered label must be in the possession of the user at the time of pesticide application.
