This amendment reflects the following revisions, additions, and corrections to the currently registered label.

- Phomopsis cane and leaf spot has been added to the list of diseases on grapes East of the Rocky Mountains.
- The rate for use on peaches in units of "lb/100 gallons" has been corrected to accurately reflect the conversion from the rate listed in units of "lbs/Acre". Specifically, the rate 1-. 1½ lbs/Acre is equivalent to ½ ½ lb/100 gallons.
- A reference to the Resistance Management Statement located in the Directions for Use section has been added to the use instructions in the "Remarks" box for the crops apples, pears, cucurbits, Eastern grapes, and peanuts.
- The line "Cerexagri does not recommend aerial application..." has been removed from the use instructions on potatoes. We now have data showing aerial applications are efficacious in controlling white mold on potatoes.
