- 1. Submit and/or cite all data required for registration of your product under FIFRA Section 3(c)(5) when the agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA Section 4.
- 2. Make the following label changes before you release the product for shipment:
 - A. Revise the EPA Registration Number to read "EPA Reg. No. 4581-412"
 - B. In the List of Ingredients section add two asterisks after "OTHER INGREDIENTS" and add the following sentence below "* Metallic Copper....":
 - "** Total arsenic, all in water soluble form, expressed as elemental, 0.00171%"
 - C. Revise the Precautionary Statements as follows:
 - "Harmful if swallowed. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."
 - D. In the First Aid block, the routes of exposure must be listed in order of decreasing acute toxicity category. Therefore, the first item in the list must be "If swallowed"
 - E. Under Warranty and Disclaimer, revise the statement "In no case shall Cerexagri or seller be liable...." to read "To the extent permitted by law, Cerexagri or seller shall not be liable...." As currently written the statement negates and/or detracts from labeling requirements as set forth by the Agency in 40CFR Part 156, and is, therefore, considered misbranding.
- 3. Submit one copy of the revised final printed label before releasing the product for shipment.

Please note that the product cited as similar (4581-395) is not considered substantially similar to 4581-412 from the product chemistry point of view. However, the Agency agrees that while different, they differ only in ways that would not significantly increase the risk of unreasonable adverse effects on the environment.
