You must submit within 6 months, (from the date stamped on this Unconditional Registration), the additional information as outlined in the Agency March 17, 1998 letter, requiring the percent of active ingredient for the following studies: 43883917, 43883918, 43883918. Additionally as outlined in a previous letter and Agency review you are required to submit additional information with regard to a developmental study, explaining the discrepancy between the purity listed in the study of 95.9% and that listed in in the study (MRID 44211601) of 95.8%. Failing to submit this information to upgrade these studies to guideline acceptable status, may result in regulatory action.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
