

PULP MILLS: To protect wood chips from Milonic 30WB Microbicide is used at 0.5 to 2 applied through a water shower or spray carrying chips from the chipper to the storag or sheet pulp, Milonic 30WB Microbicide is fiber. It is applied to the surfaces of the dewa plicator rolls.
