Subsequent Dose: Subsequent slug additions of 6.2 to 18.6 fl ozs of DEARCIDE 722 per 1000 gals of water (50 to 150 parts per million) should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleed-off and severity of the microbiological problem.

Slug additions should be made in the sump of cooling towers.

Air Washers: DEARCIDE 722 is used to control bacteria in industrial airwashing systems that maintain effective mist eliminating components.
